## A Message from our Head of School



The new academic year has begun well, with increased enrollment, the return of Latin I, the addition of Spanish II and Algebra I, part 1, and new laptops for 18 teachers. We're in the process of setting up a pottery studio on the lower level of the Bon Ton house, where we've installed our kiln. All of our fifth graders are participating in performance-based music classes, and over 90% of our middle school students are on JRDS athletic teams (volleyball, soccer, cross-country) with wins under their belts. The Eighth Grade Leadership Council has grown, with subcommittees to promote school spirit,

design social activities and field trips, create a student newspaper, start an 8th grade mentor/tutor corps, and even work on maintenance problems!

Our community understands the importance of giving to the Cardinal Fund every year. We know that each gift is essential to maintaining and building our academic and extracurricular programs. While other local schools are facing cut-backs, JRDS is growing and thriving. We are so appreciative of the strong parent support of our school! Last year, 98.6% of our families gave to the Cardinal Fund, topped only by the Board of Trustees (100%) and the faculty and staff (100%). Grades K, 1, 2, 3, 5 and 6 all had 100% participation. JRDS has always depended on a strong partnership with parents, and so many of our traditions are possible because of parent volunteers.

JRDS continues to build our role as community resource to the greater Lynchburg area. In 2010, we were the fortunate recipients of a grant from the Greater Lynchburg Community Trust that allowed us to purchase a fantastic new sound system that we debuted at Grandparents' Day. We will use that sound system for a public lecture by Rosalind Wiseman (nationally known author of *Queen Bees and Wannabees*) on Thursday, November 3, at 7pm, in the Carrington Field House. New Vistas School is a sponsor of that lecture. As forward-thinking independent schools, we are proud to bring educational opportunities to all the parents in our town.

The Cardinal Fund surpassed its 2010-2011 goal of \$200,000, raising \$209,000 for James River Day School. We are counting on our families, trustees, and friends to continue their strong support in 2011-2012. We depend on your generosity to be the great school that we are!

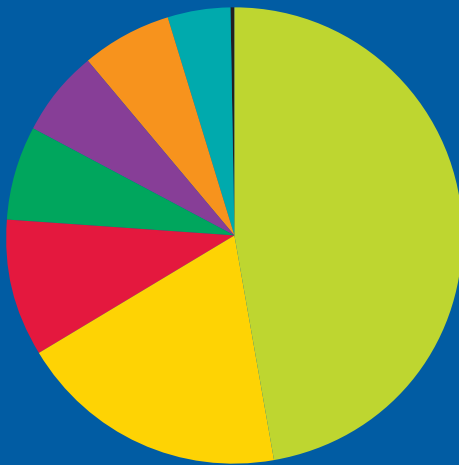
